Round table: Putting Science into Standards: the example of Eco-Innovation, 24–25 April 2013, Brussels

The Joint Research Centre (JRC) of the EC, together with the EU Association of Research & Technology Organisations (EARTO), the EU Standards Organisations (ESO), the EU DG Enterprise & Industry (ENTR) are launching a pilot initiative, within the context of the EU Forum for Science & Industry, to bring the scientific & standardisation communities closer together entitled “Putting Science into Standards: the example of Eco-Innovation”. The EC Communication ‘A strategic vision for EU standards: Moving forward to enhance, accelerate the sustainable growth of the economy by 2020’ notes that “the speed of the standardisation process must be improved if we want EU standards to play a global role”

It goes on to note that science has a crucial role to play in this respect. To address this challenge the EU Forum for Science & Industry seeks to create an environment whereby regular communication can occur between science, industry, standards. Screening of emerging science and technology is facilitated, areas which should be introduced early into the process of standardisation in order to enable innovation are identified. The output of this conference is to establish an agenda for action, to be implemented by the relevant policy and funding authorities.

FP7 - Guide to Financial Issues" updated

Due to the recent adoption of the new Financial Regulation, the related change of the FP7 Model Grant Agreement, the Guide to Financial Issues has been updated to reflect the introduction of a number of revised rules, these are:

- Reduction of the time -limit for payment of pre-financing to 30 days from the entry into force of the grant agreement
- Reduction of the time -limit for payment for interim and final payments to 90 days from the receipt of the reports.
- Abolition of the coordinator's obligation to open and operate an interest- bearing bank account;
- Abolition of the coordinator's obligation to declare, reimburse to the EC the interest generated by the pre-financing.

All changes apply as from 1 January, 2013, both to future and on-going grant agreements.

Maximising the use of research infrastructures in Europe; An on-line map to locate the facilities

This action has been instrumental in enhancing EU researchers' access to the infrastructures they require to conduct their research, irrespective of the location of the facility. It is now possible to see on an on-line map the location of about **800 research infrastructures** that open their doors to all researchers in EU. This map shows the location of the research infrastructures funded under the FP7 **that provide transnational access to researchers**. The facilities are located in **42 countries**. They cover **a large range of scientific fields** and are very diverse: from biobanks, marine stations, research aircrafts, to databanks, supercomputers and large-scale installations such as telescopes and synchrotrons facilities.

Europe 2020 strategy focuses on the capacity of the EU economy to foster growth and create jobs, especially through the Innovation Union Flagship initiative.
